

# Beyond A Shadow of A Doubt

Much has been said about Obama, including his own statements, that he is a Christian and striving to uphold the integrity of the United States of America. Nothing could be further from the truth!

This quote was further published in The Israel Today Newspaper. Obama's other statements are seen in a speech that he proclaimed the effect of Islam on his life. "I have known Islam on three continents that is the experience that guides my convictions." Apparently whatever guides a person's convictions establishes their agenda, or belief structure.
