



Two Peas In A Pod

When using the expression two peas in a pod, we refer to people that are intrinsically alike due to their psychological makeup. This article will deal with two such subjects.

Barack Hussein Obama and William Jefferson Clinton have a great deal in common, more than what most people realize. Not only do they share an arrogant demeanor, but their regard for the people of the United States is very similar.

They are of the translucent personality type. Webster defines translucent as, permitting light to pass through, but diffusing it so that persons, objects, etc., on the opposite side are not clearly visible. His signing of a second waver gave Loral the ability to sell an encrypted telemetry control ground station to China for the Loral Globalstar satellites. This ground station contained encryption that should have been under the jurisdiction of the State Department. Clinton bypassed the State Department sanctions on the export of satellite encryption to China. The CIA and the Defense Department were greatly opposed to this action because it transferred missile guidance technology to China posing a direct threat to our national security.

Regarding national security and Obama's actions, we see a similar danger. On December 29, 2009, Obama wrote Executive Order 13526, regarding the establishment of a National Declassification Center. This order prescribes a system that has created loopholes without consideration for a residual effect re-

garding highly sensitive information relating to defense against transnational terrorism.

The aspect of association with terrorists is common ground for Obama and Bill Clinton. Both have a number of friends that are terrorists that exchange favors for money and favors in light of specific personal agendas.

Obama's "friends" are Ali Abunimah the head of the Arab American Action Network in Chicago. He is extremely anti semetic and supports groups that subscribed to terrorism.

Hany Saqr is still another associate of Obama. Saqr is none other than the top leader of the North American Muslim Brotherhood.

Fund raisers were done for Obama by Khalidi in the elections for his Senate seat in Chicago. Another friend of Obama is Siraj Wahhaj, an unindicted co conspirator in the 1993, WTC bombing case.

Mark Rudd another associate of Obama's is a known terrorist participated in terrorist training camps in Cuba set up by Soviet KGB Colonel Vadim Kotchergine. This is a confirmed fact by the FBI.

Al-Mansour aka Don Warden, is a black America that is a friend to Obama and the the advisor to Saudi Prince Al -Walid Bin Talal.
